We refer to the telephonic conversation of today between your Ms Philay and the witness and confirm that according to the police, the aforesaid patient of West Vaal Hospital, a motor vehicle which collided with an animal, then left the road overtake and crashed.

- In the light of the foregoing, we are of the opinion that the victim has a valid claim.
- In the circumstances we have already closed our file. However, we have advised the police version of how the accident took place substantially differs with the witness version. We suppose one has to decide which version is probably and possibly true. We submit that sound reasons to doubt the version of the police. Our decision was based on these reasons.

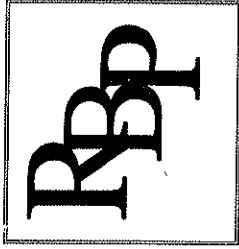

RE: YOUR THIRD PARTY CLAIM

We are surprised by your latest letter.

It is a fact that you consulted with Mr B Rom of this firm in June 1996 concerning a possible third party claim arising out of a motor vehicle accident of the 4 July 1994.

As was explained to you in order for a person to be successful in any third party claim they have to prove that the accident was due to the fault of another vehicle. Although you advised us that the accident was due to a motor vehicle moving into your path of travel causing you to swerve off the road to avoid the collision the police report stated that the accident was caused by your vehicle striking a "bees" in the road. As your details appear on this report as the driver of the vehicle we can assume that you related the details of the accident to the police.

Mr Rom requested on numerous that you supply us with contact details of witnesses to the accident to verify your version of the accident as there would be no claim as against the Road Accident Fund if your vehicle, with you as the driver collided with a Bees.

You however did not respond to any of the letters or telephone calls.

In the circumstances given that there is no independent proof as to how the accident occurred besides the police report. Due to the fact that you failed and or neglected to furnish us with the necessary information and failed to furnish us with your instructions, your claim as against the Third Party prescribed and we had no alternative than to close the file and write off the fees and disbursements owing by you to us.

It must also be advised that the Attorneys acting for the West Vaal Hospital as against the Road Accident Fund for the costs you incurred whilst you were in the hospital also closed their file in the matter as they were of the opinion that you did not have a valid claim in light of the version of the accident as detailed in the police report.

It is therefore not correct that this claim has been approved by the Road Accident Fund in June 1999 and we have never received any monies from the Road Accident Fund in this matter. We would like to speak to your "reliable sources" about the misinformation that they are giving you. Please give us their details.

We once again wish to point out that your matter as against the Third Party Claim has prescribed and that we have closed our file herein, writing off all the costs owing by you for work done and disbursements paid out.

We regard this matter as finalized.
