SWORN STATEMENT

The purpose of this statement is to motivate a Protection from Harassment Application against Mr Tony Beamish ID no. 640527 5089 089. I request the Protection Order for the following reasons:-

- 2.1 Beamish continuously 'baits' me and provokes me into getting angry with him. He does it intentionally.
- 2.2 Beamish then uses his phone to video me going off at him.
- 2.3 Beamish has threatened to send the videos he has made to my boss, at my part time job.
- 2.4 Beamish also said he would send the videos to the Legal Practice Counsel 'LPC' in order to terminate my future career.
- 2.5 In or about the end of **May** beginning of **June**, this year Beamish sexually assaulted me whilst I was sleeping in my bed at home.
- 2.6 During **2018**, Beamish assaulted my brother, Jaco van der Merwe with a wine bottle causing stitches in his head.
- 2.7 I believe that Beamish will sexually assault me again, or that he will beat me, or worse.
- 2.8 Beamish previously blocked my car in and prevented me from leaving my house.
- 2.9 Beamish once called the police and tried to get me arrested by telling them lies about me that I was being violent.

Moder

In order to explain why I need the protection order it is necessary for me to sketch some background to events.

4

I first met Tony Beamish about 5 years ago. At the time my mother, Cornelia van der Merwe 'Cora' was working for a law firm Ronald Bobroff & Partners. I saw Beamish at my house. My mother-introduced him to me as a friend. She said that Beamish had come to South Africa from France to stand by my mother as a result of the fact that my mother was having problems at work, due to allegations concerning alleged theft of documents from Bobroffs.

5

Soon after I met Beamish, I found that he was romantically involved with my mother. He often stayed overnight and sometimes stayed for a whole week and slept in my mother's room. My brother Andri found them having sex in the Jacuzzi and was shocked about it. Beamish brought my mother a sex toy. It was a battery operated penis shaped dildo which was white and purple with the brand name "OVO". I was once shocked to find this on my own bed-side table in my bedroom and believe that Beamish put it there.

6

In order to show what an un-balanced person Beamish can be it is necessary for me to relate some things I can directly remember. I shall do this subject by subject:-

THE BOBROFFS

7

The things I can recall concerning the Bobroffs, which I consider to be 'not normal' are as follows

7.1

I was aware that Beamish would set up multiple fake e-mail addresses and use these to send e-mails to the Bobroffs. I know this because he would often brag about it. Although he never mentioned the actual names of the e-mail addresses, he would say things like:

"The Bobroffs will never know it was me" and "Now I can play a few games with them."

It seemed to me that when he bragged about e-mails he was sending to the Bobroffs, he was deriving a lot of pleasure from it. I recall thinking at the time that he was 'obsessed' with the Bobroffs.

7.2

At one stage Beamish said that he phoned the school of Darren Bobroff's children and sent them everything about the Bobroffs that was on Carte Blanche. I recall my mom at the time, although she had previously protected Beamish from criticism, now told Beamish that dragging the children into it was a low thing to do. After this criticism from my mother, Beamish changed the story and said something like "Actually it wasn't me that contacted the school. There is a group of 5 or 6 people, set up by Discovery to 'spy' on the Bobroffs. It was one of the others in the group that contacted the school". Beamish did not say who the other members of the 'spy' group were.

Mudh

Beamish took a great deal of pleasure from the fact that Darren Bobroff is now an Uber driver. He would often say this and claim credit for it by saying it was because of him, Beamish, that Darren Bobroff was only an Uber driver.

7.4

Beamish would often brag-about getting R40,000.00 from Webber Wentzel-because of what he haddone to the Bobroffs and said the Bobroffs could never come back to South Africa or they would be arrested. He even hands out business cards with his name on the front and the Webber Wentzel logo on the back, where it says "Journalist of the Year".

PAUL O'SULLIVAN

8

I have first-hand knowledge of the following obsession Beamish has with regard to Paul O'Sullivan. I believe he also derives a lot of pleasure from attacking Paul O'Sullivan as he has bragged about how he got my mom to open a case against Paul O'Sullivan for kidnapping.

8.1

It was Beamish who put the idea of opening a kidnapping case against Paul O'Sullivan into my mom's head. My mom did not want to go along with the kidnapping story, but Beamish insisted she should do it. My mom was very traumatised by the whole thing and sat down and cried and said she could not go on with it. However Beamish forced her to do it because he wanted to make a story for Carte Blanche. I recall my mom crying her eyes out and saying she could not go on with it, but she had to do it so Beamish could have something to write about.

8.2

Beamish bragged after Paul O'Sullivan had been arrested off the plane with his daughters that Paul O'Sullivan would be prosecuted. I recall both Beamish and my mom often mentioned the name Kobus Vlok, who I understand was a 'friend'. I do not know where Kobus Vlok fits in.

Most of the time when Beamish would be at our house it seemed the only thing Beamish could ever talk about was Paul O'Sullivan, the Bobroffs or the Judges he knows such as Judge Bertelsman and Judge Desai. In respect of Bobroff, he would brag about how bad he was and the same about Paul O'Sullivan.

In respect of the Judges, he would brag about how well he knew them. I recall I once said to my mom that if the Bobroffs and Paul O'Sullivan didn't exist anymore, they would have nothing to talk about. Even if my little brother, who was a teenager at the time, was tired of hearing about the Bobroffs and Paul O'Sullivan. I can say honestly that Beamish is obsessed by them.

ModM

JACO VAN DER MERWE 'Jaco'

9

I wish to explain how violent Beamish can get, when he loses his temper and the effect on him of alcohol.

9.1

First I should say that, in my opinion, Beamish is an alcoholic and cannot control the amount he drinks. He would sometimes drink a whole bottle of whiskey in one night. He would also drink gin, vodka and red wine. In fact, he would drink whatever is there to be consumed. I recall he once got drunk last year and started throwing his money around out of his wallet. I recall it was R200 notes.

9.2

It was sometime last year when a fight broke out between Beamish and Jaco. I do not know for sure what it was about. I understand Beamish thought Jaco was rude to him and an argument ensued.

Thereafter Beamish took a wine bottle and smashed it on the back of my brother's head. He did it from behind when my brother was not watching. Thereafter, Jaco wrestled Beamish to the ground. Beamish somehow managed to escape the wrestling with my brother and he and my mom then got out of the house and drove off. My brother had to go to the clinic and get stitches. I don't know where he got the stitches, but assume it was at Medi-Park in Rooihuiskraal.

10

I met Tony Millar at my mom's 50th Birthday Party, at a restaurant in Pretoria. That would have been April 2015. I am aware that Beamish and my mom both say that Tony Millar is Beamish's best friend. My mother used to carry out cost-consulting work for Tony Millar, but that stopped this year. I am also aware that Beamish instructed Advocate van der Sandt to act for my mother. I don't know if he paid, or if he got van der Sandt to do it *pro bono*.

11

When Beamish gets upset he makes strange noises. I can describe these noises like 'whining' noises and in high pitch. By way of example, sometime in August 2019, when he was at our house, he got very angry when he found out that my mother had not paid one of the accounts. He then went into the garage on his own and started making these high-pitched whining noises. He did these funny noises for about 15 minutes. I asked my mom why he was doing this and she said "Don't worry, he will calm down soon". I then realised that he carries on like this with my mom. On two occasions, I think it was last year, he would start making crying noises and would then start repeating the words "I'm stressed, I don't know what to do". He would do this whilst walking around in his room that he sleeps in.

He would repeat this over and over in a high-pitched voice. He would do this for about half an hour and my mother would have to comfort him and calm him down.

12

I do believe he suffers from paranoia. At one stage we were going somewhere and crackers started going off. We could see the green crackers in the sky. Beamish then pressed the panic button on his phone, told my mom to jump the red light. Then he called the police and told them someone was shooting at him.

MudM

I recall once in **2015**, Beamish turned up at my student accommodation with my mom and said he was scared because someone wanted to kill him. I then found a guest house for him to stay at in Lynwood.

14

In June 2019, myself and Beamish got into another argument. We would often get into arguments because I don't like him. The reasons I don't like him are many. He uses and abuses my mother. He uses her for money. He makes her pay all his bills, for example if they eat out, she must pay. When he comes to stay he does not contribute towards food and alcohol. He gets my mom drunk and then sleeps with her. I would go so far as to say he totally controls her.

15

In this June 2019 argument Beamish told me he would come to the house, whether I liked it or not. This was about a month after he had sexually assaulted me. I will describe the sexual assault later. Anyway, after this argument, I knew that Beamish would start drinking alcohol again. I was very angry and went into the kitchen and took a bottle of wine and some glasses and threw them on the floor. After doing this I went to my room to calm down. Then I decided to leave and get away from there.

However, when I went to get into my car, to leave and get into my car to leave, I found my car blocked by my mother's car to block me in. I was desperate to get away so I got into my mother's car to move it. However Beamish had taken the keys.

16

Thereafter the Police arrived and I discovered Beamish had called them. I don't know what lies he told them, but they sided with him. He showed them the broken glass and said I was unstable. The Police would not listen to me. I told them I wanted to go, but they would not instruct my mom or Beamish to move the car. I then decided to leave on foot, but the police would not allow me to do so. I felt completely trapped. I think it was after this that Beamish became worried.

17

Sometime after this, I felt so hopeless and alone and I took too many "stressam" tablets which I had been prescribed after the sexual assault. After I took too many tablets and realised what I had done, I called my mother and told her. She then took me to Unitas Hospital in Centurion. When Beamish found out about this, he said he would use my 'instability' to get a court order to appoint a curator over me. After this my brother informed me that my mother told him that they want to appoint a curator over me.

SEXUAL ASSAULT

18

I now wish to explain about the sexual assault that took place and how it has affected me and left me in fear of Beamish. This happened in end of May/beginning of June 2019. I don't remember the exact date, but can connect it to the night before a tree was cut down in our complex.

Beamish had visited us again and it was clear that he intended staying as there was a lot of drinking going on.

18.2

I want to pause to mention that by this stage, although Beamish would often sleep with my mom, the two of them had pretended to the outside world that they were just friends. They made this pretence, because it did not fit in with Beamish's Carte Blanche work.

In this regard, my mother and Beamish worked together on a Carte Blanche story involving a Body Corporate concerning alleged bullying on two elderly people. My mom helped Beamish with the story, which included taking the old people out for lunch, which she paid for. When Carte Blanche found out about the involvement of my mom they put Beamish off the story.

As a result of the foregoing my mom and Beamish made a pact to deny any form of a sexual relationship and he would then stay in the spare room when he visited us.

18.3

Returning now to the night of the sexual assault, I want to mention that Beamish had been drinking a lot. He also made my mom drink a lot. My mom drank so much she became helpless.

18.4

I was lying in bed and it was about 22h00 and I heard a commotion coming from the bathroom. I got out of bed and went to look to see what was going on. The power was out, but Beamish had the flash light of his phone on and my mother was sitting on the floor and Beamish was busy undressing her. By the time I came there she was having only her panties on. Beamish was only dressed in dark trousers with no shoes and no shirt.

18.5

I then asked Beamish "What do you think you are doing". He did not reply, he just gave me a strange look. I then told him to get out of the bathroom and he then left and went to his room, being the spare room. I then helped my mom to get up and she staggered to her bed with my help. She then lay down on the bed and passed out.

18.6

I then closed my mom's bedroom door and went back to my bed. I think Beamish's room door was closed by then. To ensure my mom would be ok, I decided to leave my bedroom door slightly open. I must have soon fallen off to sleep myself.

18.7

Sometime in the middle of the night, whilst I was fast asleep, I was awoken with the feeling of Beamish's hand in my pyjama bottoms. When I awoke, I felt a presence and found Beamish bending over me with his right hand inside my pyjama trousers. I was lying on my back. I felt his hand, it was warm and was on my crotch. I was wearing panties and his hand was not only inside my pyjamas but also inside my panties. When I realised what he was doing, I started kicking at him. I was in total shock and my voice was gone. Beamish also did not say anything, he just left the room.

MidM

After this, I felt so traumatised I did not know what to do. I was afraid to tell my mom. I realised that if I did not step in to protect her when she was drunk, Beamish would probably had sex with her and I would not have been abused. She may be angry with me.

19

I eventually decided to get the courage to go to the police on **2019-07-13** at Wierdabrug. When I told the police what happened, they called a male counsellor, by the name of Rommel van der Riet. He will be able to confirm that I have discussed the sexual assault with him. His number is **082 447 5349**.

20

Whilst I do not now have the dates, I recall telling my mom and my uncle 'Stoffies' about the sexual assault. When I told my mom, I said I wanted to go and get a protection order against Beamish, as I fear him. She told me that she would agree not to allow him in the house again and I would not need the protection order. This sort of calmed me down a bit, but I still went for trauma counselling. Now I fear his very presence. He is not part of our family and I want my mom to keep her word and keep him out of our house, so he cannot hurt me again.

GROUNDS OF URGENCY

21

Despite my mom agreeing to keep Beamish out of our house, she announced on Saturday 2019-12-14 that Beamish would come and stay for a few weeks, over the Christmas period. I said I would not allow him to come and stay as I fear for my own safety and well-being. I also told her that she had agreed not to let him in the house.

22

However, it is clear to me that Beamish has some sort of a 'hold' over my mother and can get her to do anything he wants. I say this because despite my protestations, she said he was coming to stay whether'l like it or not.

23

I therefore decided of my own accord, to prepare for and apply for a protection order. To prepare for the protection order, I started drafting notes on an exam pad, which I then intended typing out. I started working on these notes on Sunday 2019-12-15, knowing that the courts would only open on 2019-12-17.

24

However on 2019-12-16, when I went downstairs to continue working on my notes for the application, I found my notes were gone. In their place in the exam pad were two pages of hand written notes on my pad in purple ink. The notes said the following:-

24.1

That she (my mother) has been working hard the last 12 months to give me space to study and that my stress was not easy for her.

MidM

She then says she can see that I want to interdict Beamish and she asks me to think carefully about it.

24.3

She then accuses me of treating her badly and breaking the bottle of wine and damage that I caused.

24.4

She then tells me in the notes that she had been to a lawyer in June and had a lawyer write a letter to me.

24.5

However she says she did not give me the letter in June because we had both come to an arrangement about counselling. She omits to mention that she promised to keep Beamish out of the house.

24.6

She then says if I go forth with the interdict against Beamish then the videos Beamish made against me will be part of the answers to the court.

24.7

She then said there were doctor's reports after I had "assaulted" her since June. I pause to mention, I have never 'assaulted' my mother. She has once hit me in the face when I told her that if Beamish did not stop bringing his laundry to the house, I would destroy it. She then assaulted me, but only lightly. She said she would send the videos of me being angry to Beamish to the Legal Practice Council, so I will not be admitted as an attorney.

24.8

Furthermore, not only did my mother take my handwritten notes, she also took my Form J480E, application for a protection order, which was partly completed, meaning I have to start again, which I am doing now.

24.9

My mother then says in her notes that if I go forward she:-

- Will not endure me anymore and I must look for somewhere else to live
- She will not contribute further to my degree
- She will sell my car and give me back my deposit of R30,000.00

25

As a result of all the above, I decided to go somewhere and prepare this application. I attach a copy of the handwritten note and the June 2019 lawyer's letter which my mother kept until now. I must also mention that Beamish on two occasions threatened me by saying if I don't 'behave' that he will send the recordings of me to my employer.

Moder

I am a student and rely on my mother's support whilst I finish my studies. I cannot afford to go and live on my own as my part-time job does not give me enough money to stand on my own two feet, although I buy my own clothes and food and petrol for the car.

I forgot to mention, the lawyers letter dated **18 June 2019**, was sent by a friend of Beamish, namely Isaak du Pisanie. I note that in that letter it alleges that I am against her 'friend'. This is a direct reference to Beamish. It is my view that although the letter purports to act for my mother, it is clearly the work of Beamish.

I thereof in closing must address the following issues:-

28.1

The letter of du Pisanie was kept as ammunition and only given to me today.

28.2

My mother took my draft notes and J480E

28.3

Beamish has his own place to live, I do not.

28.4

I fear the further sexual assault from Beamish

28.5

I fear my mother has shown my notes to Beamish, which describes his sexual assault against me.

28.6

I fear that if Beamish realises he will be exposed he will lose control and possibly kill me.

I therefore request the following:-

29.1

That the honourable court grant an interim protection order to prevent Beamish from coming to my home, or making indirect or direct contact with me.

29.2

That the honourable court set a return date convenient to the court and/or Beamish should he wish to oppose it.

n vall

That considering I do not know the address of Beamish that the court orders it to be served on my mother, in person and by e-mail to both my mother and to Beamish and also at the offices of Carte Blanche, his employer.

29.4

I will make a duplicate sworn statement and the duplicate will be given to the SAPS at Centurion to open a docket for sexual assault in that, on or about a date in May 2019, at no. 7 Domicile, Eldo Glen Estate, Centurion, the said Beamish did unlawfully and intentionally enter the bedroom of myself whilst I was sleeping and did unlawfully and intentionally put his hand into my pyjamas and onto my crotch and that by such conduct has committed the offence of SEXUAL ASSAULT.

I therefore request the protection of the court, in terms of Act 116 of 1998 and also request the police to investigate a case against Beamish of sexual assault.
