4. We indicated that with negligence on the part of another vehicle a claim could be made against the Road Accident Fund (RAF).

5. If you did not in any way contribute to the MVA, then you should be entitled to compensation in full (subject to any capping that may be imposed by law in regard to past or future loss of income). If however you are considered to have contributed to the accident, your recovery may be reduced by what is called an "apportionment of liability", so may be less than 100%.
