I was involved in an accident on 24/08/2008 at 20h30 in Natalspruit. The accident took place next to my house. I was walking on the side of the road and it was dark at the time. An unidentified vehicle lost control and hit me. I was unconscious for about 2 weeks. 2 weeks later I woke up in Natalspruit Hospital. I had a fractured skull and other injuries.

I was in hospital for 2 months. I do not remember when I spoke to Jabu but it was when I was still in hospital.

While still in hospital my sister-in-law was visiting and Jabu approached me. It is not clear to me what we spoke about because I was still confused. I could not write or understand anything and know that I did not sign any documents. When I was discharged Jabu took me home.

Jabu used to return to my house to take me to at Natalspruit Hospital about twice a month after I left hospital. Jabu took me a few times to physiotherapy and at other times took a taxi.

During the time I was going to physiotherapy I did not go to the offices of Norman Berger at any stages.

I was never told how I was going to be charged for the work done by Norman Berger or how the claim worked at all.

In the beginning of my case the only time I heard from Norman Berger's offices was when a lady named Thembi used to call me and tell me about doctor's appointments. She then sent a guy named Mandla to fetch from my house and take me to Norman Bergers offices where I would then wait with others and then go in a group to the doctor's appointments. At Norman Bergers offices I never moved from the reception room or waiting room unless to use their toilet.

Some time later they called me to tell me that my court case would be on 29 July 2011. Before the court case I had a meeting with an advocate with who I think was called Norman Hill about 4 weeks before the court date at the offices of Norman Berger.

On the court date I went straight to court and was told to sit on the bench .The advocate I had met was not there. I met a Mr Miller and this was the first time I consulted with Mr Miller.

After some time another white gentleman came to me where I was sitting on the bench and showed me a printout of an offer which was R 1 200 000.00. He told me I will not get R1 200 0000 but he did not explain to me how much less I would get or why it would be less.

After court I was taken back to Norman Bergers offices. The receptionist said they will call me to make an appointment at a later stage. They gave me no documents. Don then took me back home.

After a few days the receptionist called me and told me to come back to their offices. Don fetched me . I met with a white lady and man who I had not met with before. They explained to me they will give me R3000.00 per month from December 2011 and the 1st payment will come in December 2011. They said I am not allowed to look after my own money.

In December I received a payment of R6000.00 and nothing else after that. As I need money I called the number on the business card which the white lady gave me. A copy of the business card is attached to this. I have tried to phone this number often as I really need money but no one ever answers.

I feel so alone. At home they have rejected me. I do not live with my family. I was a driver before the accident, but when I came out of hospital, I could not drive and lost my job. My memory was very bad but now it is a bit better.

I now live with my friend. My extended family do not want me living there as I do not work or bring any money home.

In 20098 I was collected by a driver from Norman Berger & Partners Incorporated at Mviyo's house and went to Norman Berger & Partners Incorporated offices.

I remained under treatment at the Heidelberg Hospital for approximately one day and was thereafter transferred to the Natalspruit Hospital where I remained under treatment for approximately one month and thereafter I was transported to the Sebokeng Hospital where I underwent an orthopaedic procedure on my hip.
- 5. While I was at the Natalspruit Hospital I was approached in my ward by an African male known to me as Jabu who advised me that he could help me bring a claim in respect of the injuries suffered by me as a result of my accident as this was what he did. He mentioned to me that he was employed by Norman Berger and Partners Inc, a firm of attorneys in Johannesburg and that he wanted me to be a client of that firm of attorneys.
- 6. Jabu had no knowledge of either me or the accident that I was involved in but apparently was walking from ward to ward trying to sign up accident victims for this firm of attorneys Norman Berger and Partners Inc . After I had received the orthopaedic procedure at Sebokeng(my treatment lasted there about five days) I returned to Natalspruit Hospital where Jabu once again visited me in a ward.
- 7. I remained at Nataispruit Hospital on the second occasion; after being transported back to Natalspruit Hospital for approximately three weeks. During that time Jabu communicated with me and took my telephone numbers and contact details.
- 8. After my discharge from the Natalspruit Hospital I lived with my husband in Jeppe Street in the Johannessburg City Centre.

- Approximately three weeks after I had moved in to my husband's apartment in the city centre, Jabu communicated with me telephonically and requested to learn whether he could collect me from my husband's flat to take to the offices of Norman Berger and Partners Inc.
- 10. Approximately a week after the telephone call I was collected from my husband's flat by Jabu and was driven by Jabu to the offices of Norman Berger and Partners Inc in Johannesburg.
