FILIFE MAURICIO MENDES POMBO


do hereby make oath and say:

1. I sustained injuries in a road accident on the 13 January 2005, and I instructed Ronald Bobroff & Partners Inc to attend to my personal injury claim.
2. After the RAF was sued, the matter came to court twice, the first time on the merits as to who was to blame for the accident and the second time to determine the value of my claim. My claim was then settled for a total amount of R4,031,789.49 together with a contribution towards the costs from the RAF and an undertaking by the RAF to pay for my future medical treatment as required.
3. I attach hereto a tender reflecting the total amount of my settlement for R4,031,789.49.
4. A total amount of R230,335.32 was recovered from the RAF in respect of costs.
5. I have been fully accounted to in respect of all moneys recovered in my claim including the damages of R4,031,789.49 and the costs recovered of R230,335.32 as referred to above and also in respect of all disbursement incurred in my claim and the agreed fee charged to me.

My husband was seriously injured in a motor cycle accident in January 2005 and ended up in hospital in an induced coma. He remained in hospital for approximately one month. He was then sent to Rehab for some time. He sustained a serious brain injury.

Before the accident my husband was self-employed as an events co-coordinator but because of his injury he was told by the doctors that he would not again be able to do that kind of work or any work.

We were devastated as literally overnight our lives had gone from being a happy family with two children, and my husband being the main breadwinner, to an uncertain future with no real prospect of my husband ever again being able to earn a living as he had done before the accident.

1. Payment to the plaintiff of a net capital amount of **R3 618 777.00** (THREE MILLION SIX HUNDRED AND EIGHTEEN THOUSAND SEVEN HUNDRED AND SEVENTY SEVEN RAND), being a gross amount of **R4 013 348.00** (FOUR MILLION AND THIRTEEN THOUSAND THREE HUNDRED AND FORTY EIGHT RAND) less the interim payment of **R394 571.00** (THREE HUNDRED AND NINETY FOUR THOUSAND FIVE HUNDRED AND SEVENTY ONE RAND) effected on 27th June 2007;

An Undertaking in terms of Section 17(4)(a) of the **Road Accidents Fund Act, 56 of 1996**, for the costs of the patient's future accommodation in a hospital or nursing home or treatment of or rendering of a service or supplying of goods to him arising out of the injuries sustained by him in the motor collision of **13th January 2005**, after such costs have been incurred and upon proof thereof;
3. The defendant also tenders, in the event of this offer of settlement being accepted by the plaintiff, to pay the agreed or taxed party and party **High Court** costs to date hereof, such costs to include:
 - 3.1 any costs attendant upon the obtaining of payment of the amount referred to in paragraph 1 above;
 - 3.2 the costs of the appointment of the plaintiff as *curator ad litem* to the patient; and
 - 3.3 the reasonable costs of the *curator ad litem*.
