Dear Adrian Gore,

You are aware that Barry Schwartzberg, Jonathan Broomberg and Jeffrey Katz have been conducting and/or permitting, what we allege, is a vendetta against me, my son Darren Bobroff and the Practice of Ronald Bobroff & Partners Inc, intended to destroy us, for what I allege is our inadvertent exposure of longstanding, illegal and immoral conduct by Messrs Broomberg, Schwartzberg and Katz, with your knowledge and approval, so as to wreak revenge against us for doing so.

I allege that the motive for the vendetta is that our inadvertent exposure of what has been done, has and will impact on the personal wealth and earnings of yourself, Schwartzberg, Broomberg and Katz, and of course if the truth of what we allege you have all done and/or you have permitted to be done, becomes widely known, this will also impact on your publically professed high values and principles, and consequently your standing in the Community.

I therefore call upon you to agree to submit yourself to the jurisdiction of the Beth Din, before whom both parties will submit evidence and agree to cross-examination. I am copying Rabbi Kurtstag, Head of the Beth Din, with this letter, and I request you to respond to Rabbi Kurtstag and me by 4 p.m. tomorrow, before we go to Shul tomorrow evening to commence our Prayers for the New Year, as to whether or not you will do so.

You will know that we are required to confess to Hashem all sins known to us and even those unknown to us, and which we may have committed unknowingly. Our Sages teach us that repentance is the foundation of Hashem's reception of our pleas that we and our families be inscribed in the Book of Life for another year and that we and our wives and children be blessed with a year of health, sustenance and peace.

Since the vendetta I refer to was launched against my son and I, in March 2011, we and our families, have not had any peace or tranquillity. It seems to us and those fellow Jews who have seen documents in our possession, who have spoken with our Jewish clients who were victims of Katz, acting obviously, with the knowledge and consent of yourself, Schwartzberg and Broomberg, and who are aware of the lengths to which you have all gone in seeking to destroy us as fellow Jews; that your conduct, and that of Broomberg, Schwartzberg and Katz, is morally repugnant.

I sincerely hope that you will not attempt, as Katz did, to evade your moral obligation as a Jew to subject your conduct to the jurisdiction of the Beth Din by hiding behind the skirt of Discovery, sending me an Edward Nathan letter alleging that because what you do, you do in Discovery's name, and that you should therefore not be judged in this regard by the moral standards applicable to a Jew.

I really do look forward to your doing the right thing as we approach the days of awe, by agreeing to submit your conduct to the scrutiny of the Beth Din and persuading Schwartzberg, Broomberg and Katz to do likewise.
